Old Quarry Golf Course respects your privacy and is committed to protecting the personal information you provide when visiting our website, communicating with us, making inquiries, registering for events, or using our online services.

This Privacy Policy explains what information we may collect, how we use it, and the choices available to you.

1. Information We Collect

- Comply with applicable legal and regulatory requirements

We will not use your personal information for purposes that are incompatible with the purposes for which it was collected.

3. Tee-Time Reservations and Third-Party Services

Our website may provide links to external systems or third-party providers used for tee-time reservations, registrations, payments, or other services.

When you leave the Old Quarry Golf Course website and use a third-party service, information you provide may be collected and processed directly by that third party.

The privacy practices of those services are governed by their respective privacy policies and terms and conditions. We encourage you to review those policies before providing personal information.

4. Cookies and Website Analytics

Our website may use cookies and similar technologies to ensure the website functions properly, understand how visitors use the website, improve performance, and support marketing activities.

We may use services such as Google Analytics and Google Tag Manager to collect and analyze information about website usage.

Depending on your location and the applicable requirements, you may be given the opportunity to accept, reject, or manage certain categories of cookies through our cookie consent system.

You may also control cookies through your browser settings. Disabling certain cookies may affect the functionality of some parts of the website.

5. Marketing Communications

If you subscribe to our mailing list, register for certain activities, or otherwise consent to receiving marketing communications, we may send you information about Old Quarry Golf Course, including news, events, tournaments, promotions, and special offers.

We may use third-party email or marketing platforms to distribute these communications.
